

## SEVENOAKS DISTRICT COUNCIL – PUBLIC NOTICE

### THE SEVENOAKS DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (AMENDMENT 1) ORDER 2010

The Sevenoaks District Council proposes to make an Order under Sections 32, 35 and 124 and Schedule 9 to the Road Traffic Regulation Act 1984 the effect of which will be to amend the Sevenoaks District Council (Off-Street Parking Places) Order 2010 with effect from 2<sup>nd</sup> April 2012 in order to revise the following parking charges:

- 1) in **Blighs** car park, Sevenoaks: to increase the 1 hour charge to £1.10, the 2 hour charge to £2.30 and the 3 hour charge to £3.80;
- 2) in the **Buckhurst 1, Buckhurst 2, Pembroke Road** (on Saturdays), **South Park** and **Suffolk Way** car parks, Sevenoaks: to increase the 2 hour charge to £1.60, the 3 hour charge to £2.20 and the 4 hour charge to £3.20;
- 3) in the **Buckhurst 2** and **Pembroke Road** (Monday to Friday) car parks, Sevenoaks: to increase the all day charge to £4.20;
- 4) in the **Buckhurst 2** and **South Park** car parks, Sevenoaks: to increase the cost of an annual season ticket to £819 per annum (£214.75 per quarter);
- 5) in the **Bradbourne** and **Sennocke** car parks, Sevenoaks: to increase the all day charge to £6.20, the two day charge to £12.40, to increase the cost of an annual season ticket for the Bradbourne car park to £1,050 per annum (£272.50 per quarter) and the Sennocke car park to £1,090 per annum (£282.50 per quarter);
- 6) in the **St James Road** and **St Johns Hill** car parks, Sevenoaks: to increase the all day charge to £2.90;
- 7) in **Bevan Place** and **Station Road** car parks, Swanley: to increase the all day charge to £3.70;
- 8) in **Darent** and **Quebec Avenue** car parks, Westerham: to increase the all day charge to £2.90;
- 9) in all applicable car parks: to amend the cost of residents' permits to £35 for a first permit, £70 for a second permit, £125 for a third permit and £250 for a fourth permit.
