Hereby declare that:

1. I am the owner of the vehicle described below.
2. I now surrender the said vehicle to Sevenoaks District Council (hereinafter called the Council) for disposal and in which in whose contents I disclaim all rights of ownership. 'All Contents' should only be fixtures and fittings of the vehicle, any extra household or other waste could result in the Council refusing to remove the vehicle.
3. No other person has any interest in the vehicle, whether financial or otherwise.

I authorise the Council to dispose of the vehicle in any manner it thinks fit and retain any proceeds from such disposal. In consideration of the Council accepting the surrender of the vehicle, I undertake to indemnify the Council and keep it indemnified from and against all actions, claims, demands, costs, losses and expenses which may be bought or made against it, or incurred by it howsoever arising directly or indirectly out of or in connection with the surrender or disposal of the vehicle, unless arising from any illegal act, negligence or wilful misconduct by the Council, it's employees, servants or Contractors.

All personal items, items of any value, parts of the vehicle that you wish to keep for spares etc **MUST** be removed from the vehicle before you return this form to the Council.

The Council will not accept responsibility for any items left in the car at the time the vehicle is collected.

The vehicle will be destroyed immediately – there will be no opportunity to reclaim possessions once the vehicle has been collected from you.
