Pitch supply

Quantity overview

The table below provides a detailed breakdown of the Artificial Ground Hockey Pitches available across Sevenoaks. This table only includes sand-dressed AGP's as 3G surfaces are not appropriate for hockey. For supply and demand analysis, any AGP's that are not full size (at least 100x60m) will not be included as they are not the required size for competitive hockey use.

Table 4 below details the availability of AGPs at sites where they are utilised for hockey club use. This has been presented in the form of match slots (= c.2 hours AGP use). Although mid-week demand is mainly for training purposes, some matches may take place therefore in the demand section of this paper, training has been converted to match slots to allow for consistent measures. The availability of AGPs at hockey sites requires sign off from England Hockey.

This table includes only those facilities that are currently available for community use and are of a suitable size for competitive hockey to be played.

Key Site Summary

Edenbridge Leisure Centre: Very old AGP in need of refurbishment. The pitch suffers from large holes in turf, poor grip and some vandalism issues.

Sennocke Centre: 2 AGPs in good condition that are hired out regularly but do not have floodlights. There are changing facilities available in the centre.

Sevenoaks Hockey Club: Site is the home of Sevenoaks Hockey Club, who are the major hockey club in the area, with around 600 junior members and 850 members in total. The current AGP on the site is almost 30 years old, with a refurbishment 11 years ago, which is of good quality. In 2015 is was used for around 1,700 hours. The club would like another AGP on the site, which they believe there would be space to the east of the site beyond the Cafe. Club would like to relocate the dugouts across to the other side of the pitch, although this would need to move the fencing. The floodlight pylons will need replacing in the near future, and the club would ideally like to fully relay the surface as well (The pitch is used for multiple sports, including lacrosse and football, and, they have links with local school and provide them with usage of the pitch) The club are only allowed 14 advertisement boards, which limits the club's ability to maximize potential advertisement revenue. There is an unused bowling green within the park, which could also be utilised for hockey provision. There is currently no proper clubhouse facilities on the site, only 2 poor changing rooms that are underneath the parks cafe.

New Beacon School: Good site with very well maintained pitches and well maintained AGP (not full sized), which is hired out every weekend. Changing facility is good but small.



Trinity School: A brand new school that opened in Sep 2016, providing a very good new build. The AGP provision is of poor quality and in need of refurbishment.

Key Club Consultation Summaries

The following is a summary of the consultation undertaken with Sevenoaks Hockey Club, focussing on their key issues and future plans. All pitch-rating comments are the opinions of the club and may differ from the impartial rating given by the site assessor.

Sevenoaks Hockey Club	850+ members and a total of 31 teams, with 11 men's, 8 ladies and a large junior section with boys and girls' teams ranging from U10s to U18s. The club have no current plans to add any new teams as they are currently working at capacity and have stated that it is currently proving very difficult logistically to allocate a pitch to every team on weekends. The club's main pitch is the AGP on Holly Bush Lane and they use the changing facilities and clubhouse at The Vine Pavilion, but they also access several other venues in the area in order to accommodate matches and training for all teams: Sennocke Centre, The New Beacon School (training only as it's not full size), Trinity School and Tonbridge School (outside the study area). The pitch at Holly Bush Lane is the most heavily used one, with bookings for Saturday all day and Sunday 9am-6pm, as well as every weekday evening (except Fridays) for training. Sennocke centre is used for approx. 5-10 hours per week, and Trinity for approx. 4-6 hours. They have rated the quality of pitches as good, except for Trinity School, which they have described as in terrible condition – the club has no choice but to use it due to high demand and lack of availability at other sites. A major need for additional pitches in the area was identified: the club has over 600 members and at some age groups they cannot accept any more players as they are at capacity. They would largely benefit from the development of new pitches as this would allow the club to keep growing. Changing facilities at The Vine Pavilion were deemed good and of a high standard, and the club have no immediate plans to develop them any further.



STAGE C SITE-BY-SITE ANALYSIS

Site-by-site capacity analysis

The table below provides capacity analysis for all hockey club AGPs in Sevenoaks. This table contains demand (in hours) from competitive matches as well as training required by local clubs.

Table 9 show shows that although there is currently some spare capacity at key sites, key sites, including Sevenoaks Hockey Club and Sennocke are either at capacity or have no capacity at peak times. During the consultation, Sevenoaks HC identified that they are at capacity during the week and are having to limit their intake of new members as no more teams can be created to accommodate them. Although the table says that there is some spare capacity on their site at mid-week or on Sundays, it should be considered that these are not necessarily 'peak hours' as they are either too late or early in the evening to be considered convenient or appealing by current or future players.



Future Demand Analysis

This section helps to forecast the estimated future demand for pitches in Sevenoaks based on the existing demand produced by the current population. This is known as a Team Generation Rate (TGR). The forecasted number of teams up until 2035 is forecasted using TGR in Table 9.

The TGR calculation shows that there will be an estimated 6 additional teams in the area with the growth relatively evenly split between the genders. The largest growth will be in junior teams with 4 of the 6 additional teams expected to be in this category. Despite this growth, demand for adult male teams will continue to represent the largest group for hockey demand (32%).



Total Capacity Analysis

This section presents the supply and demand balance findings hockey appropriate AGPS (both for current and future scenarios) for Sevenoaks and its sub-areas. Analysis and key findings have also been identified for each of the sub-areas.

Table 10 has presented key balances but should be viewed with the following in mind:

- Compared to the other two sub-areas, the Sevenoaks and Surrounds has the largest supply and demand for hockey
- Although the table shows there is a surplus of hours, the club has identified the need for sites local and available at sociable hours and local to the club
- The club considers its home pitch to be at capacity
- Only other floodlit training facilities available are at Trinity School which the club has rated as poor to use for hockey and has been as scored poor in our site assessments, therefore, although the hours are available for use, this is far from a favourable situation
- The clubs preferred alternative training pitches, at Sennocke Centre, score significantly better than Trinity School but do not have floodlights so cannot be used for midweek training or for very many hours during the winter period.

As 95% of hockey demand in Sevenoaks is located in Sevenoaks and Surrounds, much of the above commentary for Table 10 applies to Table 11. Table 11 does allow a slightly clearer vision of the supply and demand in the town of Sevenoaks as Table 10 is slightly distorted by the balance figures for Edenbridge and the South.

Table 11 provides the following insights:

- Given that Trinity School, which has been categorised as poor by both the club and the site assessment scores, provides 10 hours of capacity on both Saturdays and Sundays, Table 11 shows a balanced picture of hockey supply and demand in Sevenoaks and Surrounds
- With these hours removed there appears to be 10hour spare capacity on weekends.
- Bearing in mind that the lack of floodlighting at the Sennocke Centre limits the amount it can be used in the winter, Table 11 begins to show how supply for hockey pitches on the weekend is reaching if not at capacity on pitches of appropriate quality.
- When the additional teams produced by the TGR calculations it is beginning to become clear that unless additional pitches are added, Sevenoaks and Surrounds with be at capacity by 2035
- It should also be considered that Trinity School accounts for 20hours of mid-week training demand for the sub-area. Given that this is not considered appropriate by the club for hockey use, the mid-week balance without Trinity School is reduced to a much smaller surplus of just 8hours per week.

Table 12 shows that there is significant surplus for hockey demand at the Edenbridge Leisure Centre. The centre reported that the majority of its capacity is taken up by informal football so the centre is occupied at other times. The table shows that there is significant capacity for the hockey club to expand and as this is the only hockey appropriate facility outside of the Sevenoaks and Surrounds, it is important for hockey's scope for progression outside of this area that it remains a facility capable of hosting competitive hockey.
