



Climate Change Action Plan December 2025

Overview

Our Climate Change Strategy (2024) marks the Council’s commitment to tackling the challenge of climate change across the District. It provides a framework for our actions aimed at reducing carbon emissions (mitigation) and adapting to the effects of climate change that are already happening (adaptation), to provide a better environment for future generations. The Strategy was agreed earlier this year and identifies six climate change priority areas to focus our efforts, ensuring we are doing all we can with our available resources to tackle the challenge of climate change.

This Action Plan follows on from the Strategy, setting out the key projects we are working on across the six climate change priority areas, to accelerate the reduction in carbon emissions and associated improvements in air quality across the District. In doing so, it seeks to harness the significant benefits of climate action to the health and wellbeing of our communities, our economy and the natural environment.

Reporting and Review

The Action Plan was initially introduced in November 2024 and is reviewed annually to track progress and maintain momentum and focus. A regular review also ensures the Plan can adapt to changes in local circumstances and aligns with the latest policy and evidence. The latest review took place in November 2025 and was considered by Members at [Cleaner & Greener Advisory Committee](#).
